Object of the Society

The object of the Society is the advancement of research, scholarship, and public education in particular by the promotion of study of the cultural history of the eighteenth century.

Principal activities

In furtherance of its objectives the Society engaged in the following main activities during the year:

- 1 Completed the production of volumes 29.3, 30.1 and 30.2 of its journal;
- 2 Held a conference at Oxford in January 2007;
- 3 Held full committee meetings in March and October and arranged for the 2008 conference at Oxford.

Review of activities and financial position

The executive committee was pleased with the activities arranged and managed by the Society during the year.

The profit for the year is set out in the statement of financial activities on page 4.

The Society's unrestricted reserves at 30 November 2007 amounted to £68,835 and restricted reserves were £4,356 making total reserves of £73,191.

The executive committee consider the financial position of the Society at 30 November 2007 to be satisfactory.


Basis of independent examiner's report
